Privacy Policy Overview

Your privacy is important to Bull Teams Only. This Privacy Policy describes how Bull Teams Only may collect, use, store, disclose, and process your personal information through your access to or use of Bull Teams Only products and services, including www.bullteamsonly.com and related offerings (collectively, the “Services”). By using the Services, you signify your acceptance of this Privacy Policy. If you do not agree, please do not use the Services. Bull Teams Only may update this Privacy Policy from time to time by posting changes and may send notification emails. Continued use of the Services constitutes acceptance of any changes.

Information We Collect

We collect information you provide via the Services, including through website input fields, phone, email, web chat, or other communications. This may include contact information (name, email, phone, address), profile details, device information (IP address, browser type), transaction information, usage data, location information (where enabled), and communications content. You may choose not to provide certain information, but some functionality may be unavailable.

Information from Other Sources

We may use cookies, log files, web beacons, device identifiers, and analytics tools to collect information about website usage and performance. You may control cookies via browser settings, though doing so may impact functionality.

How We Use Information

We use personal information to operate, improve, and personalize the Services; process transactions; communicate with users; provide customer support; comply with legal obligations; and for legitimate business purposes. Marketing emails include unsubscribe instructions.

How We Share Information

We share information with trusted partners, service providers, vendors, and contractors as necessary to operate the Services. We may also disclose information in response to legal process, to protect rights and safety, or in connection with corporate transactions. We do not sell personal information. Public posts on social media or public forums are accessible to others and are your responsibility.

Aggregated Information

We may publish or share aggregated or de-identified information that does not identify you personally for analytics, reporting, marketing, or research purposes.

Data Storage and Security

Personal information may be stored in the United States or other jurisdictions where we operate. We use reasonable technological and organizational safeguards, including encryption, secured communication channels (TLS), and restricted system access. However, no system is completely secure.

Data Retention

We retain personal information as long as necessary for operational, legal, accounting, audit, fraud prevention, and enforcement purposes. Retention periods are determined based on legal requirements and business needs.
